Q: Will a magnetic clip sized  $3 \times 2 \times 1 \frac{1}{2}$  be accepted for submittal?

A: Yes, a magnetic clip sized 3 x 2 x 1 ½ is acceptable since it is substantially close to 2 % X 2 X 1 ½.

- Q: Some vendors only provide blank samples. Is it acceptable to provide the blank sample along with a virtual including imprint?
- A: No, blank samples with virtual imprints/logos will not be accepted. Actual samples should include a logo as an example of the vendor's print quality, but the logo does NOT have to be an SCEL logo.

**Question 4** 

- Q: Item 4121 is a discontinued item. In the event that there is not enough stock when the PO goes through, would procurement consider a similar item that closes less than 30" (30" close is rare)?
- A: Yes, SCEL will accept a quote and an actual sample for an alternative Umbrella that closes as nearly to 30" as possible. Please ensure SCEL has the opportunity to inspect an actual sample of the alternative umbrella proposed in order for the alternative to be deemed acceptable by SCEL.

Question 5

Q: Please confirm that a pre-production sample is not required.

A: Electronic pre-production proofs ARE required. Actual pre-production proofs are welcome but are not required.

- Q: Will this be awarded to one bidder?
- A: Yes, one bidder will be awarded for all 3 items.
