Yes, as the preferred method of receiving graphics is via Electronic Transfer, vendors may be outside the USA; however, as vendors may need to come to attend meeting(s) at the SCEL Office in Columbia, S.C., vendors should be aware that the individual vendor would be responsible for transportation costs.
