Any information on a solicitation provided to one vendor must be provided to every vendor. To avoid any possible confusion, questions must be received in writing and a written amendment is issued answering the questions. For solicitations valued above \$10,000, the amendment document is posted on the SCEL Procurement Webpage, to the right of the Solicitation Number.

Vendors should monitor the website to check for amendments and will need to acknowledge they had the opportunity to read any amendments posted when sending their quote. There are several ways to acknowledge an amendment. By identifying the amendment number and date and printing out the table 1) after the Bidding Schedule in the solicitation or 2) at the end of each amendment posted vendors acknowledge receipt of amendments. Vendors may also 3) sign and return the amendment or 4) acknowledge by letter.
