**Question 1**

Q: Would it be acceptable for the imprint area on the wrap be 2 1/2 x 5 rather than 2 x 5?

A: Yes, SCEL will accept this size of imprint.

**Question 2**

Q: Would an alternative size be accepted for the Chill Wrap (17 x 26 or 33 x 13)?

A: Yes, SCEL will accept either of these sizes.

**Question 3**

Q: Could the Chill Wrap be shrink wrapped rather than in a box case?

A: No, SCEL would like these as indicated from the solicitation: Custom EVA Ice Chilly Towels with Box Case

**Question 4**

Q: The Mini Golf Bag will be on an extremely tight production time given the in hands date of 3/22/17 and the fact that samples are not to be submitted until the lowest bidder is announced. Is there any possibility of an extension of the in hands date?

A: No, SCEL needs these items by the week of March 20, 2017, no later than noon on Wednesday, March 22, 2017.

**Question 5**

Q: The imprint for the golf tees states the SCEL logo will be used. The imprint area for the tees is 1 x 1/2. Can you confirm the logo to be used and supply it in vector format with the solicitations answers to be posted on 2/17/17?

A: SCEL will accept both our logo and SOUTH CAROLINA EDUCATION LOTTERY imprint on the tees. SCEL will provide art files to the winning bidder. See logos for examples.
