2. What is the quantity for Curvy Stylus Ball Pen?

A. The total quantity for each requested item is 2,000; therefore, the total quantity requested for the Curvy Stylus Ball Pens is 2,000.

Total Quantity: 2,000: "Fantastic Five" Cooler Combo Packs.

Each "Fantastic Five" Royal Blue Cooler Combo Pack must contain each of the following four promotional items fully assembled and pre-packaged within each (1) Royal Blue Color-Block Cooler Bag: (1) 16 oz. Royal Blue Tumbler with Matching Royal Blue Colored Straw, (1) Royal Blue Notebook & Pen Combo, (1) Royal Blue LED Flashlight, and (1) Royal Blue Curvy Stylus Ballpoint Pen. (Crestline Product, "Fantastic Five" Item #112069) or similar product deemed acceptable by SCEL.

3. Is a sample required with bid?

- A. Samples are not required to be submitted with bids as stated on page 11 of the Solicitation. Although samples are not required to be submitted with bids, SCEL does require the Vendor to submit actual pre-production proof samples with an SCEL logo for each of the requested five items. If awarded, the Vendor must receive approval from SCEL for the actual samples with the requested SCEL logo before final production can begin.
- 4. Since you need delivery by mid October, and produce all goods overseas which will take 45-55 days after sample approval, will the bid be rejected for not being able to meet the delivery date?

I doubt that even purchasing domestically that one can meet that date with the sample approval process taking up at least 2 weeks, to produce the samples, ship them, and wait for approvals.

A. Yes. A bid will be rejected for not being able to meet the required delivery date.

The "Fantastic Five" Cooler Combo Pack is available for purchase domestically and is able to meet the required delivery date based on the distributor's standard production schedule below.
