VENDOR #1

QUESTION #1: We would like to know what was your last awarded price for Promotional Items bid?

SCEL RESPONSE: The promotional items requested in Solicitation #FY20PROMO1AIFB06122019 have never been solicited, nor procured, in accordance with the specification requirements provided in the Bidding Schedule Worksheets in Section 8.2; therefore, historical pricing information is not available.

VENDOR #2

QUESTION #2: Since these items are coming from different factories, is it ok for different items to arrive on different days from each other and is delivery before August 16th ok?

SCEL RESPONSE: As provided in this Solicitation*, the full order (for each item) **should** be delivered by August 16, 2019; and, may be delivered prior to the delivery date upon request of the Contractor(s) awarded the bid(s). Since award will be made by individual item, more than one Offeror may be awarded; thus, it is reasonable for SCEL to expect different items to be delivered on different days.

*See "Section 3—Scope of Work/Specifications, Part 3.3--Delivery Date - Specified"; and "Section 6 –Award Criteria, Parts 6.1—Award by Item and 6.3—Award to Multiple Offerors" as provided in this Solicitation.

QUESTION #3: For the magnetic clip, is this size ok? Product size 3"H x 2"W instead of the 2 7/8"H x 2"W requested. Also the imprint area would be 1.25"H x 1.5"W instead of the 1.25"H x 1.25"W requested.

SCEL RESPONSE: See **SCEL RESPONSE** to QUESTION #5 from VENDOR #3 below.

CONCERN (VENDOR #2): With the tariffs taking place on July 1st, I just want to make sure that everyone is quoting post tariff pricing so that nobody gets caught in a bad pricing situation. Most of these items will not be effected, but some will.

SCEL RESPONSE: SCEL recognizes that the tariff increase currently imposed by the U.S. may affect promotional items imported from China. If a bidder chooses to supply SCEL with promotional products impacted by these tariffs, then a bidder must take those changes into account when submitting pricing in response to Section 8.2 and Attachment 1.

VENDOR #3

QUESTION #4: The Memo Clip is screen printed, not laser engraved. Please confirm that this imprint method is acceptable.

SCEL RESPONSE: Yes. Screen-printing is an acceptable imprint method for Offerors to use when submitting bids for Item #6-- Magnetic Memo Clip (Red) as provided in Section 8 of the Bidding Schedule of this solicitation.

QUESTION #5: Can the Memo Clip be 3"H x 2" W with an imprint of 1 ½"H x 1 ½"W?

SCEL RESPONSE: Yes. SCEL will accept bids from Offerors for Item #6-- Magnetic Memo Clip (Red) that are sized 3"H x 2"W with an imprint area of 1 ½"H x 1 ½"W.

QUESTION #6: Two of the listed items currently have 0 inventory in one of the colors requested, but expect shipments to replenish their inventory the latter part of July. Could the in hands date be extended by 2 weeks?

SCEL RESPONSE: The Bidding Schedule Worksheets in Section 8.2 clearly express the following: "if the requested color for a promotional item is out of stock, or is not available for the total quantity being requested, then BIDDERS MAY provide a substitute color(s) for that item." However, if the requested color of an item is currently out of stock, but the Bidder expects the requested color for that item to become available at a later date with an expected delivery date that is two weeks after the preferred delivery date of August 16, 2019, then the Bidder should provide this information in their response. SCEL will take these factors, including any partial delivery requests, into consideration when making an award for each item.
