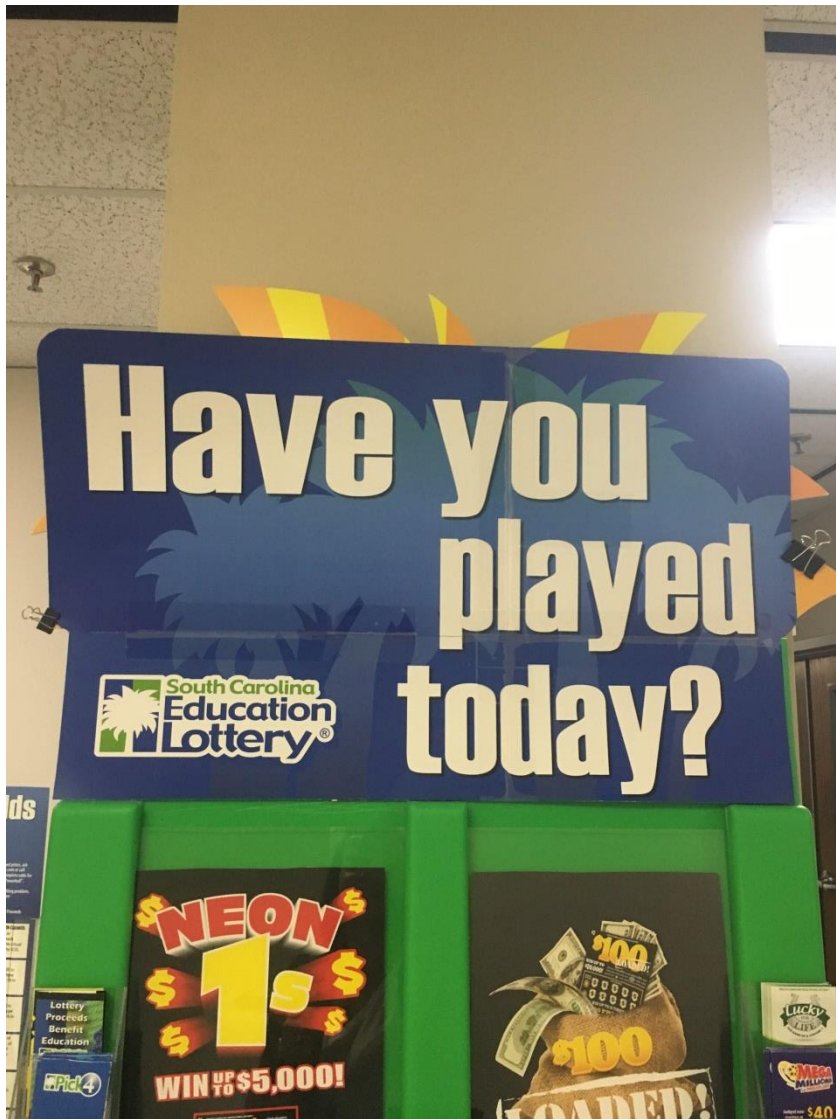

Play Stations are available at every retailer licensed by the South Carolina Education Lottery and serve as repositories of lottery information. Players may obtain Play (Bet) Slips, Claim Forms, Terminal Game and Instant Ticket Information, End-of-Game Dates, information regarding current Second-Chance Promotions, etc. at the Play Station.**



### Question 2

**Q: What is the use of it?**

**A: The use of the Play Station Topper is to provide additional advertising on where to find the Play Station at a retail location. The “Topper” piece is attached to the highest part of the Play Station to assist players in finding the Play Station and the lottery**

**information it contains. The “Topper” advertising piece is the item being solicited NOT the Play Station. Should the Play Station happen to be located in a retailer’s window, the Topper would be a readable advertisement that the location sells lottery products.**

**Question 3**

**Q: Any previous history of qtys and price**

**A: Play Station Toppers were last ordered in March of 2015. Only 500 Toppers were ordered at a price of \$3,860, or \$7.70 each.**

**NOTE: The old toppers were made of a different substrate and adhesive (.060 mil white styrene and permanent adhesive), whereas the current solicitation is for 4mm white coroplast and five (5) pieces of Foam Tape per sign. Additionally, the old toppers were in a jagged star burst requiring a custom die. The new sign is in rectangle with rounded corners. The new solicitation is for 5,000 Toppers, not 500.**
